- Participation at the BIOEAST Conference "Bioeconomy in the forefront of national policies" on 8 Nov. 2018, Budapest
 - Agreement on follow-up co-operation between BIOEAST and ICA-Bio on Education and Training for bioeconomy in order to strengthen the European perspective
- Workshop in Prague on 19 Sept. 2019 on the development of a Community of Practice (CoP) on Bioeconomy Education
 - Follow-up meeting on 15 October 2019 in Brussels



Proposed future actions:

Potential contributions of ICA-Bio to the development of Community of Practice (CoP)



- ICA offers the possibility of an umbrella for networks across
 Europe focusing on Education for the Bioeconomy
- Proposed at the CoP preparatory meeting on 15 October 2019 in Brussels:
 - Currently discussion with two networks; open for further networks

 → Community of Practice (CoP)?
 - ICA provides the advantage of directly linking to Rectors and Deans of agricultural and life science universities
 - ICA Bio should continue to mainly focus on Education for the Bioeconomy

Proposed future actions:

Potential contributions of ICA-Bio to the development of Community of Practice (CoP)



Continued:

- Future aim of ICA-Bio should be to develop a CoP to explore the issues relating to the development of curricula for/in the Bioeconomy
- Proposal of an ICA-Bio Colloquium "Education for the Bioeconomy Colloquium" in 2020
- At that colloquium a new Executive Committee of the ICA-Bio should be elected, including candidates of the other CoP members
- Josef Glössl would continue high level engagement e.g. GBS 2020, proposed UNESCO conference in 2020, and with the EC
- In the meantime JG would continue to report to the ICA Board on ICA-Bio developments
