## 7 Report of the ICA Treasurer – to be approved Paper 2 ICA Accounts and Treasurer's Report for 2019 Paper 3 ICA Budget 2021 Paper 4 Extract of the Auditors' Report 2020 of the 2019 Accounts The Treasurer will make a verbal report at the General Assembly based on his written **Treasurer's report in Paper 2.** The General Assembly is asked to approve the Accounts and Treasurer's Report for the year 2019 and grant Board members discharge from any liability. Paper 3 proposes the budget for 2021. It anticipates support under Special Provisions (row 45 and following) for the ICA Board Committees, ICA-Edu (1.800€) and ICA-Bio (3.200€), and for the IROICA ICA Standing Committee (3.000€). It also anticipates a provisional budget for the support of the ICA Task Force Co-ordinator of a maximum of 22,000€. The total expected withdrawal from reserves in 2021 is 30,000€ may reduce the reserves close to the agreed minimum level of 50.000€. The ICA General Assembly is asked to agree on the Budget 2021 including the withdrawal of 30.000€ from the reserves. 8 Membership subscription rates 2021 – to be approved The ICA Board proposes that the membership subscription of full members for 2021 be raised from 1250€ to 1300€ in line with the internal ICA rules for adjustment of the membership subscription due to inflation. The membership subscription was last raised to 1250€ for the 2014 subscription year. Other membership subscriptions will be adjusted pro-rata 9 **Revised ICA Statutes** – to be approved Paper 5 Revised ICA Statutes 2020 A commentary outlining the reasons for the revision of the Statutes is written before the start of the listing of the revised Statutes in Paper 5. 10 ICA Board Elections – to be voted Paper 6 Nominations for Elections to the ICA Board 11 ICA Board Proposal to appoint an ex-officio member of the ICA Board – to be approved ICA Board proposes the appointment of Dean Alex Evans, University College Dublin as an ex-officio member of the ICA Board to enable him to continue to Chair the ICA Board Sub-Committee for the ICA Task Force. Alex Evans is currently ICA Vice President but steps down from the Board at the 2020 General Assembly having served two terms of office. The Board proposes that he should continue to Chair the the ICA Board Sub-Committee for the ICA Task Force. 12 Proposal to suspend at 31 December 2020 members for non-payment of the membership subscription – to be approved International Centre for Advanced Mediterranean Agronomic Studies 13 Appointment of Auditors for the 2020 accounts - to be approved To re-appoint Marzina Ganc (WULS) as lead auditor. A second auditor to be appointed by the Board.

## Representation at the General Assembly

The General Assembly is open to all staff and students from ICA Member Institutions, **all** are most welcome to participate in the meeting. Each ICA Member Institution [which has paid the ICA membership subscription for 2019] has a right to cast one vote in the meeting. This vote will normally be cast by the ICA Institutional Contact (rector, head of college/school, or dean) of the ICA Member Institution, or his or her proxy.
